



## **Rules and Regulations** **Notice to Holiday House Patrons**

ENTRY UPON HOLIDAY HOUSE RECREATION CENTER PREMISES SHALL BE DEEMED A REVOCABLE PRIVILEGE AND THE WEST ROCKHILL-SELLERSVILLE JOINT RECREATION AUTHORITY/COMMISSION RESERVES THE RIGHT TO BOTH REQUEST THE REMOVAL AND TO REMOVE FROM THE PREMISES ANY PERSON WHO, IN THE SOLE JUDGMENT OF THE MANAGEMENT/STAFF OF HOLIDAY HOUSE, BEHAVES IN A DISORDERLY OR OTHERWISE IMPROPER MANNER.

1. Badges must be presented in order to be admitted into pool. Badges are not transferable. Violators of badge transfer will be dismissed from the pool for the balance of the season.
2. Holiday House property and recreation facilities are smoke free. Smoking is permitted in the parking lot beyond the pool entrance.
3. No one in pool under **10** years without adult supervision. (18 years or older)
4. Ages **11 thru 15** must be supervised by someone over 16 years of age.
5. No running within fenced area of the pool.
6. Rough play is prohibited in and out of pool area. (Excessive/undesired splashing or dunking, hanging on the head, neck, shoulders, etc.)
7. Foul language is prohibited on all Holiday House property.
8. No bicycles, skateboards, or shoe skates are permitted on sidewalks, tennis courts, basketball/squash courts, or inside of pool area.
9. Alcohol is prohibited on all Holiday House property.
10. No glass containers allowed on Holiday House property.
11. Street clothes are prohibited in pool. Swimming suits must be worn in the pool. T-shirts are acceptable over swimsuits.
12. Children who wear diapers must use approved models.
13. Gum is prohibited within fenced area of the pool.
14. Toys are allowed in the 2 ft. (Baby Pool) section of the pool. Appropriate types and uses of toys are left to the discretion of the lifeguards. Toys are prohibited in all other areas of the pool.
15. The diving board is the only designated diving area. There will be no swimming in the diving well. However, treading is allowed in the diving well during designated adult swims.
16. Place all trash in proper trash receptacles.
17. We are not responsible for lost or stolen items.
18. In case of the first sign of lightening and/or thunder, we must clear the pool immediately. Pool will not reopen until 30 minutes after the last lightening and/or thunder occurrence.
19. The use of proper flotation devices is permitted with adult supervision. Please see chart of approved flotation devices at office.
20. The use of goggles is permitted, if used properly except for goggles that cover the nose.
21. Baby pool is for children 6 years and under.
22. Adult swims – A. 18 years and over  
B. (1) child 6 years of age or younger is permitted in with an adult
23. No chairs permitted on deck area.
24. Prolonged breath holding is not permitted in the pool.
25. Individuals must shower with soap and water before entering the pool.
26. Individuals under the age of **13** must pass a swim test before being permitted to use the diving board and rock wall. Upon passing the swim test, individuals will be issued a wristband. There will be a \$1 fee for lost wristbands.
27. No running is permitted in the sprinkler area. Do not block the sprinklers or touch the bucket.
28. In the event of one or more of the following circumstances, Holiday House Pool reserves the right to close the pool: low attendance, bad weather, staffing availability, and private events.
29. No ball playing in fenced area of pool.
30. Only certified service dogs allowed in pool area.
