## APPLICATION FOR PROVISIONAL EMPLOYMENT UNDER THE CHILD PROTECTIVE SERVICES LAW (CPSL)

In accordance with requirements of the CPSL, as amended, I hereby apply for provisional employment up to ninety (90) days with the West Rockhill-Sellersville Joint Recreational Authority and in support thereof, I do hereby swear and affirm that:

1. I have applied for a child abuse clearance certification from the PA Department of Human Services and have provided West Rockhill-Sellersville Joint Recreational Authority with a copy of the Pennsylvania Child Abuse History Clearance Form I submitted to the PA Department of Human Services;
2. I have also requested a report of criminal history record information from the PA State Police (PSP) and a federal criminal history record information report from the Federal Bureau of Investigation. I have given West Rockhill-Sellersville Joint Recreational Authority a copy of my PSP Request for Criminal Record Check and COGENT confirmation receipt for my required F.B.I. criminal record check;
3. I have not been named by the Department of Human Services in the statewide database as the perpetrator of a "founded report" of child abuse committed within the last five (5) years from the date of this application, nor have I been convicted of one or more of the following offenses in the Pennsylvania Criminal Code (including any attempt or conspiracy to commit those offenses), or any equivalent crimes under federal law or the laws of another state:

Chapter 25 (relating to criminal homicide);  
Section 2702 (relating to aggravated assault);  
Section 2709.1 (relating to stalking);  
Section 2901 (related to kidnapping);  
Section 2902 (relating to unlawful restraint);  
Section 3121 (relating to rape);  
Section 3122.1 (relating to statutory sexual assault);  
Section 3123 (relating to involuntary deviate sexual intercourse);  
Section 3124.1 (relating to sexual assault);  
Section 3125 (relating to aggravated indecent assault);  
Section 3126 (relating to indecent assault);  
Section 3127 (relating to indecent exposure);  
Section 4302 (relating to incest);  
Section 4303 (relating to concealing death of child);  
Section 4304 (relating to endangering welfare of children);  
Section 4305 (relating to dealing in infant children);  
A felony offense under section 5902(b) (relating to prostitution and related offenses);  
Section 5903(c) or (d) (relating to obscene and other sexual material and performances);  
Section 6301 (relating to corruption of minors); and  
Section 6312 (relating to sexual abuse of children);

4. I have also not been convicted of a felony offense under Act 64-1972 (relating to the Controlled Substance, Drug, Device and Cosmetic Act) committed within the past five (5) years; and
5. I understand that I must be dismissed if I am named as a perpetrator of a "founded report" of child abuse within the past five (5) years or have been convicted of any of the crimes listed above.

I hereby swear/affirm that the statements set forth above are true and correct to the best of my knowledge and belief. I also understand that the penalty for false swearing is a misdemeanor of the third degree to Section 4903(b) of the Criminal Code.
