

ORDINANCE NO. 714

AN ORDINANCE OF THE BOROUGH OF SELLERSVILLE, BUCKS COUNTY, PENNSYLVANIA, AMENDING CHAPTER 152 OF THE CODE OF THE BOROUGH OF SELLERSVILLE TO CLARIFY CERTAIN ONE-WAY TRAVEL RESTRICTIONS AND TO PROHIBIT PARKING ON CERTAIN AREAS OF EAST CHURCH STREET

WHEREAS, Sellersville Borough Council finds that certain existing Ordinances pertaining to one-way travel restrictions should be clarified to better express the intent of said Ordinances; and

WHEREAS, Sellersville Borough Council finds that the design, width, and layout of East Church Street between North Main Street and Penn Street does not allow for the safe and efficient parking of motor vehicles on the south side of East Church Street.

NOW THEREFORE, BE IT ORDAINED AND ENACTED by the Borough Council of Sellersville Borough, Bucks County, that the Code of the Borough of Sellersville (the "Code") is hereby amended as follows:

Section 1. Section 152-10 of Article II, Chapter 152 of the Code is hereby amended by deleting it in its entirety and replacing it with the following:

§ 152-10. One-way streets established.

The following are established as one-way streets, and it shall be unlawful for any person to drive a vehicle on any one-way street other than in the established direction of travel as set forth below.

Street	From	To	Established Direction of Travel
Maple Avenue	North Main Street	West Temple Avenue	Westbound
Walnut Street	North Main Street	East Temple Avenue	Eastbound

Section 2. Section 152-11 of Article II, Chapter 152 of the Code is hereby amended by deleting it in its entirety and replacing it with the following:

§ 152-10. One-way streets established at certain days and times.

The following are established as one-way streets at certain designated days and times, and it shall be unlawful for any person to drive a vehicle on any one-way street in the prohibited direction of travel on the days and times set forth below.

Street	From	To	Prohibited Direction of Travel	Days	Hours
East Church Street	High Street	North Main Street	Westbound	Sundays	7:30 a.m. to 12:00 p.m.
Green Street	High Street	North Main Street	Westbound	Sundays	8:00 a.m. to 12:00 p.m.

Section 3. Section 152-15 of Article III, Chapter 152 of the Code is hereby amended by adding the following:

Street	Side	Between
East Church Street	South	North Main Street and Penn Street

Section 4. If any sentence, clause, section, or part of this Ordinance is found for any reason to be unconstitutional, illegal, or invalid by a court of competent jurisdiction, such unconstitutionality, illegality, or invalidity shall not affect or impair any remaining provisions, clauses, sentences, sections, or parts of this Ordinance.

Section 5. This Ordinance shall become effective immediately.
